CONTRIBUTION METHODS:

We encourage you to choose the option you are most comfortable with — see below for the available options. Also, please remember St. Brigid of Kildare Church in your estate plans.

#1—EFT / AUTOMATIC WITHDRAWAL: **18-19 update needed for all EFT users*

If you are already one of the 1,000-plus St. Brigid of Kildare families using automatic withdrawal through the Electronic Funds Transfer (EFT) method of making your church offertory gift, THANK YOU! For the 18-19 year, we will need all current and new EFT parishioners to fill out their bank information on the opposite side and return this card in order to continue processing your pledge. EFT is a safe and convenient processing service that allows you to electronically transfer your offertory gift from your checking account, savings account or credit card to the church's account.

#2 — WEEKLY ENVELOPES:

You may choose to receive weekly envelopes from the parish so that you can contribute through the weekly offerings at Mass, or give weekly utilizing either personal checks or bank auto pay.

#3 — “BILL ME” PLEDGE REMINDERS:

Choose this option if you would like to be mailed a pledge reminder (invoice) so that you can contribute through the mail or at Mass.

#4 — ADDITIONAL WAYS TO GIVE:

Other ways to give include a one-time gift through check or our parish website, a gift of stock, or by using a donor-advised fund.
